5. If an election is contested the poll will take place on THURSDAY 7 MAY
6. New applications to vote by post and requests to cancel or change an existing postal or proxy vote must reach the Electoral Registration Officer at ROTHER DISTRICT COUNCIL, TOWN HALL, BEXHILL-ON-SEA, TN39 3JX by 5pm on 21 APRIL, if they are to be effective for this election
7. New applications to vote by proxy except on the grounds of an emergency must reach the Electoral Registration Officer at ROTHER DISTRICT COUNCIL, TOWN HALL, BEXHILL-ON-SEA, TN39 3JX by 5pm on 28 APRIL, if they are to be effective for this election
8. Applications to vote by proxy on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at ROTHER DISTRICT COUNCIL, BEXHILL ON SEA by 5 pm on 7 MAY. The physical incapacity must have occurred after 5pm on Tuesday 28 April 2015. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Tuesday 28 April 2015
