This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</p>

<sup>1</sup> Beneficial interest could include land or property which you own, or have a right to occupy (e.g. a tenancy) or receive an income from. This will usually include your home address.

<p><b>Securities<sup>2</sup></b>            Any beneficial interest in securities of a body where—            (a) that body (to my knowledge) has a place of business or land in the area of the Council named above; and            (b) either—</p> <p>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or</p> <p>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which I or my spouse or partner* has a beneficial interest exceeds one hundredth of the total issued share capital of that class.</p>

<sup>2</sup> "securities" means shares, debentures, debenture stock, loan stock, bonds, units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.


