Sedlescombe Neighbourhood Plan and Representations

David Marlow has asked me to contact you, in his absence, on a couple of matters regarding the Sedlescombe Neighbourhood Plan.

A couple of minor errors have been drawn to our attention and I would like to highlight them to you:

1. **SED-R16-2017-296** – Representation SED-R16-2017-297 was uploaded onto our website twice, in error as SED-R16-2017-296 and SED-R16-2017-297. The correct rep for SED-R16-2017-296, from Julia Chapman has now been uploaded to the website¹ and is attached to this letter for your records.
2. **SED-R16-2017-508** – The wording in the comments summary has been amended to make it clear that the same respondent who also made comments at SED-R16-2017-101, makes additional comments in the second submission, rather than duplicate comments as originally stated.
3. **SED-R16-2017-34** and **SED-R16-2017-35** – Although ‘Policy 7’ is quoted within their respective representation forms, on re-reading, it is clear that these relate to ‘Policy 11’, so the summary is being amended accordingly
4. **SED-R16-2017-456** – ‘Policy 11’ should be stated in the Policy No. column, rather than ‘Policy 10’, as already stated in the Comment Summary

As a result of the mail out to consultees to confirm that the representations received during the consultation have been duly made, we have been contacted by Mrs S Gornall (Mrs S Cornwall - SED-R16-2017-258) who states that she did not make a representation to the Sedlescombe Neighbourhood Plan and that there is no-one at her address with the name stated on the representation form. As such, this representation has now been rejected and has been removed from the website. The respective entry in the spreadsheet has been updated. I therefore respectfully ask that you now disregard this representation.
